Staff Reports

<u>T. Warner – Community Engagement and Trails Coordinator</u> – report attached. Indicated that he would like to hold more community snowshoe trail walks this winter. D. Brothwell – great work on trails and asked for some sort of skid plate for cross-country skiers. G. Black – asked for possibly extending the farmers markets.

<u>H. Gropp – Community Development Officer</u> – report attached. Thanked the municipal team for all their help with some unforeseen challenges at the parks this fall. Expressed a huge thank you to everyone for going above and beyond, and without asking. Handed out copies to council of a new community marketing flyer. Indicated that it was taken to Toronto with NWEMS recently

as part of their package for paramedic recruitment. It is also used by school boards for teacher recruitment efforts. Reported that there will be a virtual session regarding the continued study of a potential accommodation tax in October. D. Brothwell – will end walls for the 4 season recreation complex be eligible in the Trillium Foundation grant. H. Gropp – it is not an eligible expense under this grant.

<u>Pioneer Parks Update</u> – copy attached, as well as copy of a draft summary from the Biologist and recently received written comments from the public in support of the Pioneer Park project.

<u>H. Chant (absent)</u> – written report submitted by Councillor Chant was read by W. Kabel, CAO. A copy is attached.

<u>D. Brothwell</u> – the Planning Advisory Committee met September 11, 2024, in Nestor Falls. They approved an application for the use of a steel storage container.

<u>S. Salvador</u> – reported that he picked up and delivered an incident board for the fire department that was purchased and donated by the Men's Breakfast Club.

<u>G. Black</u> – reported that she attended a Sioux Narrows Recreation Committee meeting September 10th, 2024, the grand opening of the Park Meadows Women's Shelter September 17th, 2024, as well as attended a tour of the new 56 unit senior housing complex on 8th street in Kenora. She also met with Ministers Rickford and the Minister of Housing at the tour event. She attended a Kenora District Municipal Association virtual meeting September 19th, 2024. Indicated that the Sioux Narrows Recreation Committee is organizing a Halloween event. She stated that she really appreciates the recreation committee volunteers for all their hard work. She has copies of the recent All Nations Health Partners meeting minutes. She will have them, as well as the Recreation Committee meeting minutes, posted along with the minutes.

Carried

Delegations

<u>S. Marden</u> – thanked council for the opportunity to speak. She explained that they have a problem with a local business who keeps their garbage in an open trailer with no cover. The garbage attracts birds, bears and other animals. It is causing damage to her business property and takes considerable time for them to clean up. They have tried to speak with the business owner. He will not respond. He does pick up garbage that is spread in the immediate vicinity of the trailer, but much more garbage has been dragged into the woods and remains there. This trailer has no cover at all. She sees the efforts of the municipality in beautifying the highway corridor and it is unfortunate that this is happening. She is asking for some sort of consideration to try and remedy the matter. Mayor Black – thanked her, is sorry to hear this and indicated that council will discuss and see if there's anything that can be done. General discussion ensued. MNR has been contacted but they can't do anything. The OPP cannot do anything without a by-law. By-Laws, if considered to enact, do take some time and there is a process and even if implemented, it doesn't always resolve every issue. But council will consider the matter.

P. Hankey Schindele - Pioneer Park - not able to attend.

<u>D. Tolen</u> – Pioneer Park – thanked council for the opportunity to speak. Stated that she asked the municipal office for zoning property maps, as well as a list of municipal properties. She did not get an answer. Municipal staff indicated that the maps are available on the municipal website and that a list would be sent to her of municipal properties. She further indicated that her vested interest in this project involves a longstanding history in this community. Her husband's family built a tourist camp on Crow Lake and a camp on Whitefish Bay. Her husband's family has over 100 years of history in this community. Discussed her concerns over the development's potential for follow through. It is possible that that the developer may not continue beyond the first stage and worries that additional vacant lots could be subdivided and sold, and that short term rentals could be established there. States that the eagle's nest is viable. If this development goes ahead, it will devalue every property in this township. Believes the municipality would be further ahead if we built affordable housing off the waterfront and seniors housing. The only ones who would benefit if we go ahead with Pioneer Park are the developer and investors. The way it was handled was unprofessional. What do we have to do to get across to council how unsatisfied we are. She asked for each council to answer why they think we should do this. G. Black - thanked her and stated that there is a shortage of housing here. We have building and planning checks and balances to go through to ensure good development and values protection. M. Rydberg - wanted to speak to a few of the items noted. Regarding seniors housing, we are in the process of this. Regarding affordable housing, we are working on that too. New housing will bring new people. We have had inquiries about this project from people who want to move here. He wants to see

the environmental report before making his final decision. D. Brothwell – stated that today is not the first time we have heard from the public. It is not new to council that there are people who are against developing Pioneer Park. We understand this. We also represent everyone, both those who are not in favour and those who are in favour. There are people who want to see growth here. This is not affordable housing. But our housing strategy, which does take into consideration data collected by KDSB for housing needs in our community, indicates that we need seniors housing, we need affordable housing, and we need market rate general housing. The Seniors housing is being developed on property that the municipality owned. We own this property too and it is worthy of consideration. He too wants to see the full report. D. Tolen heard M. Rydberg say that this has been in the works for several years. Council indicated that the first RFP went out in 2022. D. Tolen - asked what will we do about precedent setting regarding allowing some site work to be done before a decision is made. J. Port – answered that public property is accessible, but that work cannot be done without authorization. proponent was given authorization. Not precedent setting. Work was authorized. D. Tolen asked about commercial development. The businesses here are struggling already, why would we permit more competing businesses. G. Black - looks at it differently. New business is healthy for growth and development in a community.

<u>B. Tolen</u> – tourism has dropped considerably since the 1940s. Feels that this project will not help businesses but will equal more seasonal residents. And seasonal residents do not support local businesses. D. Brothwell – said that council has heard the concerns. But, there is something to be said about seasonal residents and what they bring to the community. They do support the community. General discussion ensued regarding local businesses and that the local business owners are best to speak to their success or otherwise.

R. Gripp – asked when that they will be able to access the environmental report. Council indicated that as soon as we receive it, it can be published as a draft report and available to see. Asked who the letter of support was received from. Council indicated Mr. Rebbetoy. It is attached to the Pioneer Park update report as all previous Pioneer Park comments have been handled and will be published along with the minutes once adopted. R. Gripp - feels it would be helpful for council to see a current real estate report about market housing, instead of referencing a study that was done post Covid. He is disappointed that the environmental report will not be received in enough time to have it independently reviewed by them and in such a short time before council has set their meeting to make a decision.

<u>G. Black</u> – indicated that the date of October 9th, 2024, for a decision was made and supported by council. We are repeatedly asked when council will receive the report and make a decision. We now have the summary of recommendations, are expecting the full report this week and now have a date set to the make the decision next week. This is what we have been asked for, now we are hearing the opposite. We cannot win.

<u>B. Salvador</u> – wished to speak to the comment about summer residents not contributing to the community. There is a local group, the Men's Breakfast Club who volunteer and contribute greatly.

<u>S. Marden</u> – she operates a seasonal business. It is not year-round. It is too difficult to do so. It is quiet in the off season, and it is hard to find staff. She is not in support of this development but is in support of seniors and affordable housing. Asked if there is a compromise regarding commercial space. Is there a way to protect what is already here. She is all for more businesses, but to add to what we are lacking not what we already have. H. Gropp - we need services. Can we prevent all the types of businesses the private sector may start? No, but perhaps we might have some influence concerning what is proposed to be developed with this project. Generally

speaking, we have done community surveys asking residents for ideas and business needs. Residents have expressed a number of wants and needs above what we currently do have.

<u>D. Anderson</u> – will the meeting that is set for council to make their decision be open. Council answered yes. Are you considering all the names, some 200, that signed the petition. Council said yes.

<u>D. Brothwell</u> –we can try to target businesses more in need. What we don't do is try to attract more businesses that we already have. We actively try to attract what we don't have.

<u>D. Tolen</u> – what if the developer builds 4 units and can't sell more. What stops him from subdividing and selling vacant lots. J. Port – we could have a take-back clause put as a condition in an agreement. This indicates that if the land is not used as proposed and remains vacant, that it revert to the municipality.

I. Trenchard – referenced the Sioux Narrows – Nestor Falls Official Plan – listed items from the plan and how they are contradicted by the development. Indicated that J. Port said that the development is currently in alignment with the Official Plan. J. Port – indicated that he did not state this. He acknowledged that there is a process in place to amend the plan. It is a living document that does see revisions, including term updates prescribed by the province that involve the Provincial Policy Statement (PPS), of which we were delayed in our OP review recently as the province put out a new PPS. J. Trenchard – speaks about the OP and asked if the RFP is in direct alignment. J. Port - if the project goes ahead, a statutory meeting would be held, an analysis done, a planning report prepared, and a recommendation made to approve it or not. It is then given to council. They may take the recommendation or not. The final decision is theirs. There is no black and white in planning. Many considerations are looked at. J. Trenchard - if there is a new Provincial Policy Statement, should this current process not be delayed to take this into account. J. Port - we already started updating the OP. J. Trenchard - appears to him that, from a governance stand point, that we are making a decision on something that is outdated. I. Port – it is not outdated. We use it all the time. It is completely functional. Development goes on. Processes continue. Including updates. J. Trenchard – regarding the proposed high density of this project. It seems to go against the OP.

<u>E. Anderson</u> – asked if we met with the natives. Council answered, yes, we met with our First Nations neighbours and Grand Treaty #3. We are also trying to arrange a second meeting.

<u>S. Marden</u> – asked about septic. Would public works need to be installed by the Township. Council answered, no, it would be the responsibility of the developer to install a suitable and certified system.

<u>J. Trenchard</u> – an RFP was issued. A project was selected for review. Appears to him that it is the densest proposed project in the area. It seems to go against the OP. We are expecting to see an environmental report less than one week before a decision is to be made. That it will be made available to the public less than a few days before council makes a decision. A road allowance was approved to be pushed through and that may be already against the buffer recommended in the environmental report. The municipality is contemplating giving the land to the developer. He questions whether something nefarious is going on. Feels that we are responsible to prevent any conflict of interest. He questions this.

<u>G. Black</u> – expressed that she totally disagrees. That she is sorry that he feels this way. No one here is doing anything that is nefarious, and no one is doing anything that isn't in the best interests of the community. J. Trenchard – feels that there is an appearance of wrongdoing, but he cannot specify what. Council indicated that this is a serious allegation and asked him to state what specifically he feels is questionable. J. Trenchard answered that it is nothing specific, he is not making an allegation, but he repeated that there is little time to review the environmental

assessment, and that council is considering giving the land away. H. Gropp – spoke to the question of council potentially gifting land. It is a common and acceptable practice in Ontario.

Capital Infrastructure Projects:

The construction of Phase II of the Nestor Falls Bike Trails commenced on Friday September 27th. The team will work at the site until it is no longer possible to do so this fall. Any unfinished work will be completed in the spring.

The Sioux Narrows Government Dock project is wrapping up. Municipal staff toured the site and identified a number of deficiencies. These are being corrected by the respective contractors. We expect that these reparations will have an impact on the useability of the playground in particular.

Health Hub Update:

The Health Hub located next to the Sioux Narrows Nursing Station Clinic began its operation in September. Two new practitioners were present in the hub offering Naturopathic Medical care, and footcare. Both practitioners are happy with the space and level of bookings. There will be a community public open house on Monday October 21, 2024 hosted by the practitioners. All community members are invited to come and learn more about the space and offerings.

Partnership Marketing Update:

In May and June 2024, we ran a partnership marketing campaign with the City of Kenora, Destination Northern Ontario and Destination Ontario focused on Lake of the Woods. This was a significant campaign targeted at Minnesota and Wisconsin. This was, once again, a very high performing campaign. I have attached the Campaign summary report to this report for your information. On a dollar per dollar basis this campaign was the best performing drive partnership campaign by Destination Ontario this past spring. Toronto did have more impressions than we did, but they also spent more money. Our advertising and in particular the Lake of the Woods messaging resonates with potential visitors in Minnesota and Wisconsin.

Ontario Trillium Foundation Trails Grant:

On October 9, the Ontario Trillium Foundation Grow Grant is open for applications. The purpose of a grow grant is to take a successful project to a next level. Grow grants range from \$100,000 to \$600,000 over 2 or 3 years. Grants support established programs and services that have a proven track record of success and meet community need. Applicants can apply for funding to expand, improve or adapt an existing program or service. Staff are seeking Council's direction to submit an application for \$100,000 per year over 3 years. (total \$300,000) to enhance and improve the work on our trails over the next three years. We have had considerably success with growing and expanding the trail network in our community. We also believe that we are increasing the trail usage, and that they are becoming a unique attraction for visitors to our community. We would use this grant to increase winter opportunities on our trails, including the purchasing of specialized grooming equipment, increase the work of the volunteer trails committee, enhance public engagement on the trails, add additional trail maintenance support, and build trail improvements. There are no matching fund requirements for this grant.


October is Small Business Month







Conclusions and Recommendations

Reedy Bay

Reedy Bay is an important wetland (marsh) providing habitat for a diversity of fish and wildlife species; wild rice harvesting opportunities for Indigenous peoples; and drinking water for local residents.

To protect water quality in Reedy Bay for fish and wildlife, wild rice and drinking water the following is recommended:

- The proposed development's septic systems must be approved and inspected by the Ministry of Environment, Conservation and Parks (MECP) and/or the Northwestern Health Unit.
- Proponent develops and implements a sediment control plan during and after construction ensuring sediment does not enter Reedy and Regina Bays.
- No surface runoff or storm sewer water from the proposed development's roads, parking lots, septic systems, residences, or landscaped areas should be discharged or allowed to enter Reedy and Regina Bays.
- A minimum 30 m. vegetation buffer should be maintained between the development and the adjacent waters of Reedy and Regina Bays.
- To alleviate the concerns regarding boat gas/oil contamination and increased boat traffic stirring up sediments in Reedy Bay, the proposed docking facility should be located in Regina Bay.
- Ministry of Environment, Conservation and Parks (MECP) should be consulted to develop a water quality monitoring program to determine predevelopment water quality and for a period after development based on MECP recommendations. If there is a decrease in water quality attributed to the development, then appropriate mitigations measures should be implemented.

To ensure no loss of fish and wildlife habitat and wild rice in Reedy Bay:

- No developments (e.g., docks, boathouses, boat launch etc.) associated with the proposed development should occur in Reedy Bay,
- No alterations (e.g., dredging, removal of aquatic vegetation) should occur in Reedy Bay.

Pioneer Park

Pioneer Park is a small area with a relatively intact forest and ground vegetation cover including mature white pines, and distinct oak/iron wood, black ash and northern white cedar stands. The area provides habitat for a variety of birds and small mammals. The proposed development will remove and replace the existing forest cover with residences, roads, parking lots, septic systems and landscaped areas.

To maintain some natural habitat for birds and small mammals the following is recommended:

- Preserve all mature white pines (living and dead).
- Protect existing oak/iron wood, black ash and northern white cedar stands and incorporate them into future landscaping plans.
- Maintain a 30 m. minimum vegetation buffer between the development and Reedy and Regina Bays.

To protect migratory bird nesting in Pioneer Park:

 No site alterations or construction should occur during the general nesting period from mid-April to the end of August.

OR

 If nests are encountered during site clearing or construction the nest tree must be protected with appropriate setbacks and timing restrictions (OMNR 2010b).

Pioneer Park Bald Eagle Nest

The most important wildlife feature in Pioneer Park is the Bald Eagle nest. A Bald Eagle nest is considered Significant Wildlife Habitat and the Provincial Planning Statement (2024) indicates:

"Development and site alterations shall not be permitted in significant wildlife habitat unless it has been demonstrated there will be no negative impacts on the natural features or ecological functions."

It is almost certain; Bald Eagles will abandon the Pioneer Park nest if the development proceeds as proposed. They may however, establish a new nest in the general vicinity and continue to forage in Reedy Bay.

If the development proceeds as planned it is recommended:

- The Pioneer Park white pine and nest must be protected (Fish and Wildlife Conservation Act 1997) and maintain a 20 m. vegetation buffer around the nest tree (OMNRb).
- Other mature white pines adjacent to Regina Bay (alive or dead) should be preserved and protected with a 20 m. vegetation buffer.
- Maintain a 30 m. minimum vegetation buffer between the development and Reedy and Regina Bays.
- Protect existing oak/iron wood, black ash and northern white cedar stands.

Bald Eagles may abandon the Pioneer Park nest, but these mitigation measures may encourage the eagles to continue perching and foraging in Reedy Bay.

The Pioneer Park nest was not used this year for breeding. It is unknown whether the Bald Eagles have permanently abandoned the Pioneer Park nest or are using an alternate nest and may return to the Pioneer Park nest in the future. If the objective is to maintain nesting and perching in Pioneer Park, a precautionary approach is recommended. This would include:

- Monitoring the Pioneer Park nest for the two breeding seasons (2025,2026)
 to determine and document whether the nest is active or inactive.
- Confirm whether there are any active alternate nests within the Significant Wildlife Habitat zone defined as the 400 to 800 m. area around the Pioneer Park nest.

Possible Scenarios

- If Bald Eagles return within the next two breeding seasons (2025,2026) to nest in Pioneer Park, then no development or site alteration should occur within 100 m. of the Pioneer Park nest tree to be consistent with the Provincial Planning Statement (2024)
- 2. If an alternate nest within 400 to 800 m. of the Pioneer Park nest is used in the next two breeding seasons (2025,2026), the area is still considered Significant Wildlife Habitat. However, the new nest is now the primary nest while the Pioneer Park nest is considered an alternate nest. This would confirm, Bald Eagles have not abandoned the Significant Wildlife Habitat and are still using the area for nesting and foraging.

In this scenario, it is highly unlikely Bald Eagles would use the Pioneer Park alternate nest in the future, if the development proceeded as planned. MNR provides no specific guidance on how to address alternate nests other than to protect the nest tree and consider it part of the Significant Wildlife Habitat. To maintain Pioneer Park as perching and foraging habitat, it is recommended:

- The Pioneer Park alternate nest tree must be protected (Fish and Wildlife Conservation Act 1997) and maintain a 20 m. vegetation buffer around the nest tree (OMNRb).

- Maintain a 30 m. minimum vegetation buffer between the development and Reedy and Regina Bays.
- Protect existing oak/iron wood, black ash and northern white cedar stands.

Recommended Option(s):

- Until it is determined and documented the Pioneer Park nest is active or inactive, no site alteration or development should occur within the 100 m. primary zone surrounding the Pioneer Park nest tree.
- The Bald Eagles must be given time to adjust to the significant clearing and disturbances that occurred adjacent to the nest tree and within the 100 m. primary zone this summer. No development (e.g., Phase 1) or site alterations should occur outside the primary zone this fall (2024) or winter (2025).
- The above recommendation could be reconsidered if Bald Eagles do not nest in Pioneer Park in 2025. If so, construction should be restricted to the non-critical period September 1, 2025 to February 28, 2026. No access roads should be built within the 100 m. primary zone until the nest is classified as inactive (e.g., after the 2026 breeding season).

Staff continue to work through our due diligence on this file at this time.

The receipt of the entire Environmental Impact Study of this project on Pioneer Park has been delayed. However, we are in receipt of the recommendations/conclusions. Attached to this report are the recommendations of the Biologist. In his recommendations, Barry Corbett goes through a number of environmental considerations for Council and lays out a number of mitigations that would permit this development to move forward, should Council choose to proceed. The final report will be delivered by the end of this week. Barry Corbett, is available to meet with Council to review the report and answer any questions, should this be of interest to Council.

There have been questions regarding the value of this development to the community and the value of the land. For Council's information the future tax revenue potential of this development is not insignificant. It is important to note that MPAC has the final say over the assessment valuations of each property. However, given the location and the base price of these properties it is reasonable to expect returns in assessment value as follows:

Assuming a \$300,000 assessment on each property, the annual tax revenue generated for phase one of the development would be \$17,906.24. The annual tax revenue generated for the entire development at this rate would be \$58,195.28.

Assuming a \$500,000 assessment of each property, the annual tax revenue generated for phase one of the development would be \$29,842.72. The annual tax revenue generated for the entire development at this rate would be \$96,998.84.

The Township received a letter of support for this project from J. Rebbetoy dated September 9, 2024. It has been attached to this report for your information.

Conclusions and Recommendations

Briefing Note

To: Rainy River District Municipal Services Association

Subject: Delivering Paramedic Services in the Rainy River District

Purpose: To outline the critical shortage of paramedics in the District of Rainy River and opportunities for support to help address challenges in the current environment.

Context:

- The Rainy River District Paramedic Service has an existing and ongoing staffing shortage. With 7 resignations in 2024 alone, the shortage has reached a critical point.
- By the end of the summer 2024, the service will be operating with approximately 30% fewer Full-Time Equivalent (FTE) paramedics than what are needed to maintain its four (4) base service delivery model (i.e., a minimum of 46 FTEs is required for the current model, the service will be operating with approximately 32).
- For the last several years to address shortages, the service has been relying on existing staff to forgo earned vacation and time-off, and to work significant hours of overtime.
 This is no longer sustainable. Paramedics have self-reported to exiting the service due to working conditions and the service is at significant risk of losing more.
- In July 2024, the District of Rainy River Services Board made the difficult decision to take deliberate action to address the ongoing strain on the organization's ability to maintain safe working conditions and provide effective service levels across the district.
- The desire of the DRRSB is to support paramedics across the district to deliver the best possible services to the citizens while respecting the challenges of a front-line service provider occupation, including a need for regular time-off and vacation.

Continuing Efforts to Address Staffing Shortages:

Temporary Staffing Solutions:

- Authorized overtime for current staff to bridge gaps
- Introduced flexible scheduling options to better accommodate staff availability and reduce burnout

Recruitment and Retention:

Attending public events to represent and promote service

- Participating in job fairs and establishing partnerships with area high schools, educational institute, and college to attract new graduates.
- Introduced incentive program to recruit staff (i.e., Learn and Stay program, Education Cost Recovery program)
- Introducing small financial benefits and non-monetary changes to retain existing staff.

Policy and Process Improvements:

- Worked collaboratively through the Labour Management Committee to make policy changes to align with and reflect previous board direction to address retention (i.e., support for increased access to physical fitness in the workplace, shift scheduling, ...)
- Improved onboarding processes to ensure new hires are well-integrated and supported from day one.

<u>Longer Term Staffing Solutions Underway</u>:

- Working collaboratively through the Labour Management Committee and with neighbouring paramedic services to explore longer term solutions.
- Working with local educational institutions (i.e., Seven Generations) to provide placements for current students in the paramedic program.
- Exploring staffing models that may better suit current and likely near future realities.

Requests for Provincial Support:

- At an August 2024 delegation meeting with the Minister of Health, the DRRSB asked the Minister to consider the following actions:
 - Support a Targeted Recruitment Campaign: Develop and implement a recruitment campaign to attract paramedics to the rural and remote areas of the province, including the Rainy River District.
 - Provide Additional 100% Provincial Funding: Allocate specific 100% provincial funding for rural and remote services to offer competitive salaries and benefits, purchase updated equipment, improve outdated and inadequate infrastructure (i.e., bases) and implement workplace health and safety initiatives (i.e., peer to peer support, mental health supports etc.) to better enable northern paramedic services, including the DRRSB, to recruit, retain and remain viable and competitive.
 - Enhance Healthcare Delivery: Continue to address the acute shortage of healthcare workers across the north broadly to improve access to family physicians, emergency paramedic services, community paramedicine, and mental health support in the district.

Background - General:

• The current service model established in 2002 has paramedic services delivered through four (4), twenty-four (24) hour stations, located in Atikokan, Fort Frances, Emo

- and Rainy River and via a small Community Paramedicine Program (i.e., 1 dedicated paramedic with occasional additional support).
- Atikokan, Emo and Rainy River require approximately 10 FTEs to operate 24 hours a day, while Fort Frances requires approximately 15 and the Community Paramedic program requires one (a total minimum need of 46).
- The district has faced long-standing physician shortages, and more recently, shortages of nurses, personal support workers, mental health professionals, and paramedics.
- Staffing shortages are a reality for Paramedic Services across the province and services are competing with one another in efforts to recruit and retain.
- The Rainy River District faces challenges that exacerbate those being experienced in more urban communities. As reported by paramedics declining offers of full-time employment and leaving the service for employment elsewhere, recruitment and retention efforts are hampered by the rural and remote nature of the district, uncompetitive salaries and benefit packages, and an inability to maintain work-life balance.

Riverside Health Care Secures Physician Services in Rainy River Through November 2024




