Reports from Committees (cont.)

N. Dufresne – reported that he and our CAO, W. Kabel, attended a Mayors and Municipal Officials meeting with our Member of Parliament, B. Nault, and the Federal Minister of Infrastructure, F. Champagne, in Kenora, March 29th, 2019. It was a roundtable discussion regarding the infrastructure needs of Kenora District municipalities, as well as the various funding programs that are currently available and possible in the future. The general sentiment is that many of the needs in the Kenora District do not meet the rigid eligibility requirements of the available funding programs. The Minister thanked us for our feedback and accepted any written presentations that were provided by the municipalities. We did provide him with a written proposal of our priority projects. Immediately afterward, we were invited to meet with our Member of Provincial Parliament, G. Rickford, who discussed the provincial Minister of Municipal Affairs and Housing, S. Clark's, recent announcement to small and rural municipalities in Ontario of a one-time payment in 2019 to assist municipalities in their efforts to become more efficient and reduce expenditure growth in the future.

Delegations

- J. Swenson & T. Gill discussed difficulties with the new fishing license vendor procedures and that there is currently only one place in Sioux Narrows, aside from some of the camps, where people can buy fishing licenses [The Trading Post]. They feel that the Sportfishing Centre would be a great place. Discussion ensued regarding the process under the new regulations, as well as the challenges. Council thanked them for their ideas.
- J. Swenson asked why that the floating artist-in-residence studio couldn't be installed at the Pioneer Park property instead of the Government Dock Bay. Clarification was provided; it makes more sense to have it located in the hub of the community, close to the services of downtown, as well as the convenience of the municipal supports available at our Sportfishing Centre, which has washrooms, telephone and internet service. As well, the idea is also to foster relationships with the local arts community in Sioux Narrows and in the central, downtown location is a better way to do this. Further, it will not interfere with any future plans to expand docking in the bay.
