<u>H. Chant</u> – Fire Rescue Service – gave a report of the Open House event, held April 25th, 2023, at Station 1. It went well and about 30 people attended. We had two new recruits apply who will start training this month. Councillor Chant expressed thanks to the Fire Chief, Fire Fighters and other volunteers who helped with the event. Reported that the Chief has ordered a new portable pump for Station 2, as well as new helmets. A flyer is going out soon for the annual smoke detector campaign. There is a possibility of declaring the oldest fire truck surplus. Nestor Falls Recreation Committee – reported that the committee received a quotation for a projector and screen for installation at the Nestor Falls Community Hall. Councillor Chant did indicate to the committee that they do need to wait for the Community Hall renovations to get underway. Discussed some electrical needs related to the installation. Reported that Mental Health Week is May 1-7. This year's theme is My Story. Events and activities organized by the Northwestern Health Unit and the Canadian Mental Health Association are ongoing in our community, as well as across the district. There was a barbeque today at the NWHU office in Sioux Narrows earlier today. Discussion ensued regarding calendar of events for the week, as well as ways to participate.

<u>S. Salvador</u> – reported that work is going to start on remediating the Lobstick Bay Road Causeway to repair damages caused by the high water in 2022.

<u>G. Black</u> – reported that our council, staff and consultants met with Onigaming's Chief, council and staff on April 26th, 2023, regarding our trail partnership. Report:

Northern Ontario Sport Fishing Centre:

Facility usage: We have received requests for the usage of the facility outside of operating hours. These requests are for community events and private functions.

The community events would be free, or low charge and are requesting use of the facility free of charge. The private event does not request free usage of the facility. We have not typically rented out the facility.

Partnership with AKRC: We are entering into a partnership with AKRC and the Sport Fishing Centre to bring new and exciting programming to the Sport Fishing Centre in 2023. We have been working out the details and will be sharing them as part of our summer programming series to the community.

Bike Trails:

We have had the awarded contractor withdraw their services for the construction of the Bike Trails in Nestor Falls. Therefore, we have negotiated with the second bidder and it is recommended that we proceed with Precambrian Trail builders on the adjusted scope of work, which will focus primarily on the enhancements and linkages of the Red Pine Trail. The new Red Pine trail description is as follows:

(New) Red Pine Trails Description

The new Red Pine Trails will expand on the existing network and will include the creation of the following trail alignments which will be signed to facilitate wayfinding for users:

- A new climb trail will provide users with a more gradual option to ascend the ridge adjacent the trailhead parking area (max. 5% slope). The climb trail will start at the trailhead and will terminate at an existing trail alignment upslope, which continues climbing the ridge to the start of the green and blue flow trail segments.
- The green and blue flow trails are one-way descents that meander through the red pine plantation. The flow trails are designed specifically for mountain bikes and will showcase numerous trail features including rollers, berms, and jumps that are positioned in a way that harnesses a rider's momentum to minimize pedaling and braking. The open understory and the mature pine forest canopy in this location provides an idyllic setting for these trails.
- The black diamond trail continues to ascend the ridge from the start of the green and blue flow trails to the ridge apex. From there, the trail begins a descent through the mixed-wood forest environment which is characterized by exposed bedrock and large glacial boulders. The trail will follow sustainable grades down the ridge and will tour users through the rugged forest environment characteristic of this location.
- Each flow trail ends at an existing trail alignment toward the bottom of the ridge.
 Trail users then have the option to return to the top of the ridge via 1 of 2 existing trails.

Marketing:

Our 2023 marketing efforts are under way. We have been working with the City of Kenora and our partners at Destination Ontario and Destination Northern Ontario on an exciting campaign into the US that will launch next month. We have also received some preliminary footage from our Media Snowmobile tour which will be very helpful next winter.
