Noted that the next All Nations Hospital Partners Committee meeting will be in June, but she is still waiting for confirmation on the date.

<u>M. Rydberg</u> – reported that both Provincial Parks are now up and running. There is a full staffing compliment at both. Seasonal site rentals are at capacity in 2019 at both parks, and both parks have waiting lists.

# **Reports from Committees** (cont.)

<u>N. Dufresne</u> – gave a report of the Sioux Narrows – Nestor Falls Police Services Board meeting held earlier today, May 21<sup>st</sup>, 2019. The locations for installation of the new speed zone signs that were given to us by New Gold have been approved by the Ministry of Transportation. Substantial provincial funding cutbacks were made that affect the Ontario Provincial Police. However, no details are yet available on how that will affect local policing services. It also appears that the funding formula may change. The Police Services Board will be looking at policing cost comparisons with other municipalities.

O'Leary – Sioux Narrows – Nestor Falls' Northwestern Health Unit Board Representative-discussed the Health Unit's request to the district municipalities to send letters of support to the Minister of Health and Long-Term Care regarding provincial changes. They are in a state of uncertainty and staff are concerned. G. Black asked about the province's initiative to reduce 35 Health Units to 10; has any direction been given on how this is supposed to be accomplished? J. O'Leary indicated that there are no details yet available. N. Dufresne – asked if any preemptive measures are being taken by the Northwestern Health Unit and the Thunder Bay Health Unit to try to work together, instead of waiting for the province to dictate a zone that could end up being much broader. Discussion ensued regarding potential changes and the uncertainty.

General discussion also ensued regarding the Emo Clinic and doctor recruitment efforts.
