

**THE CORPORATION OF THE  
TOWNSHIP OF SIOUX NARROWS - NESTOR FALLS**

BY-LAW NO. 163

Being a by-law to prohibit or regulate the discharge of guns or other firearms, air-guns, spring-guns, cross-bows, long-bows or any other weapon

---

WHEREAS the Municipal Act, S.O. 2001, c. 25, s. 119, provides that a municipality may, for the purpose of public safety, prohibit or regulate the discharge of guns or other firearms, air-guns, spring-guns, cross-bows, long-bows or any other weapon;

NOW THEREFORE the Council of the Corporation of the Township of Sioux Narrows - Nestor Falls ENACTS AS FOLLOWS:

1. Except as provided herein, no person shall discharge any gun or other firearm, air gun, spring-gun, cross-bow, long-bow, or any class or type thereof, within the limits as shown on Schedules A, B & C (the land contained therein) attached hereto, and forming part of this by-law, in the Township of Sioux Narrows - Nestor Falls except on premises used especially for that purpose, approved by the Township of Sioux Narrows - Nestor Falls, or by persons entitled by law to carry guns or other firearms, air guns, spring-guns, cross-bows, long-bows or any class or type thereof.
2. That the Council of the Corporation of the Township of Sioux Narrows - Nestor Falls may, in writing, authorize a person, or persons, to discharge a firearm for the sole purpose of nuisance animal control, and any regulations under which the firearms may be discharged.
3. That the Council of the Corporation of the Township of Sioux Narrows - Nestor Falls may, in writing, authorize a person, or persons, for firearms displays, and any regulations under which the firearms may be displayed.
4. That any person who contravenes any of the provisions of this by-law is guilty of an offence and upon conviction is liable to a fine or penalty as provided for in the Provincial Offences Act.
5. Where any by-law passed prior to this by-law conflicts with this by-law, the terms of this by-law shall prevail.
6. That by-law number 122 be repealed at the date of final passing of this by-law.
7. That this by-law come into force and take effect upon the date of final passing.

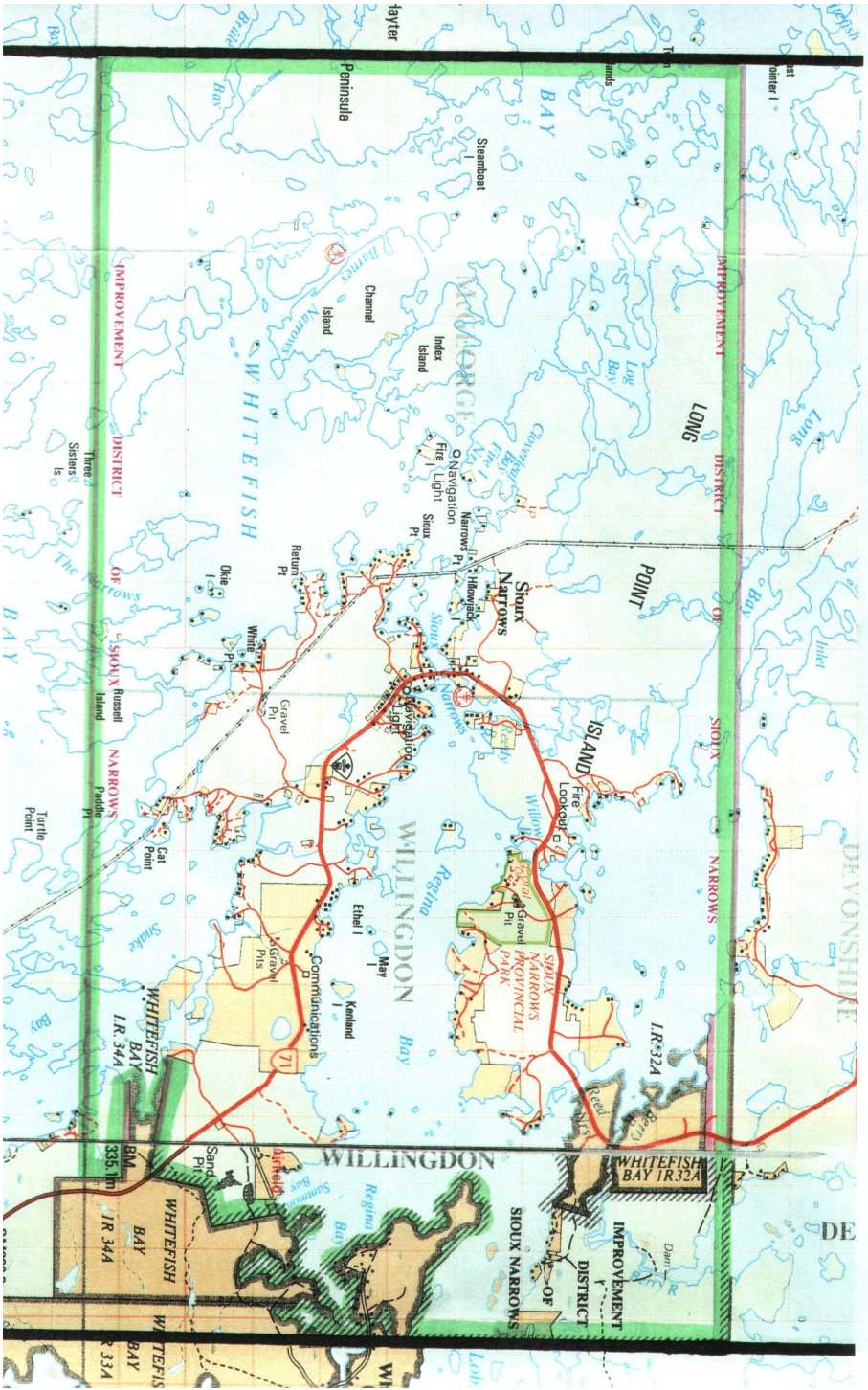

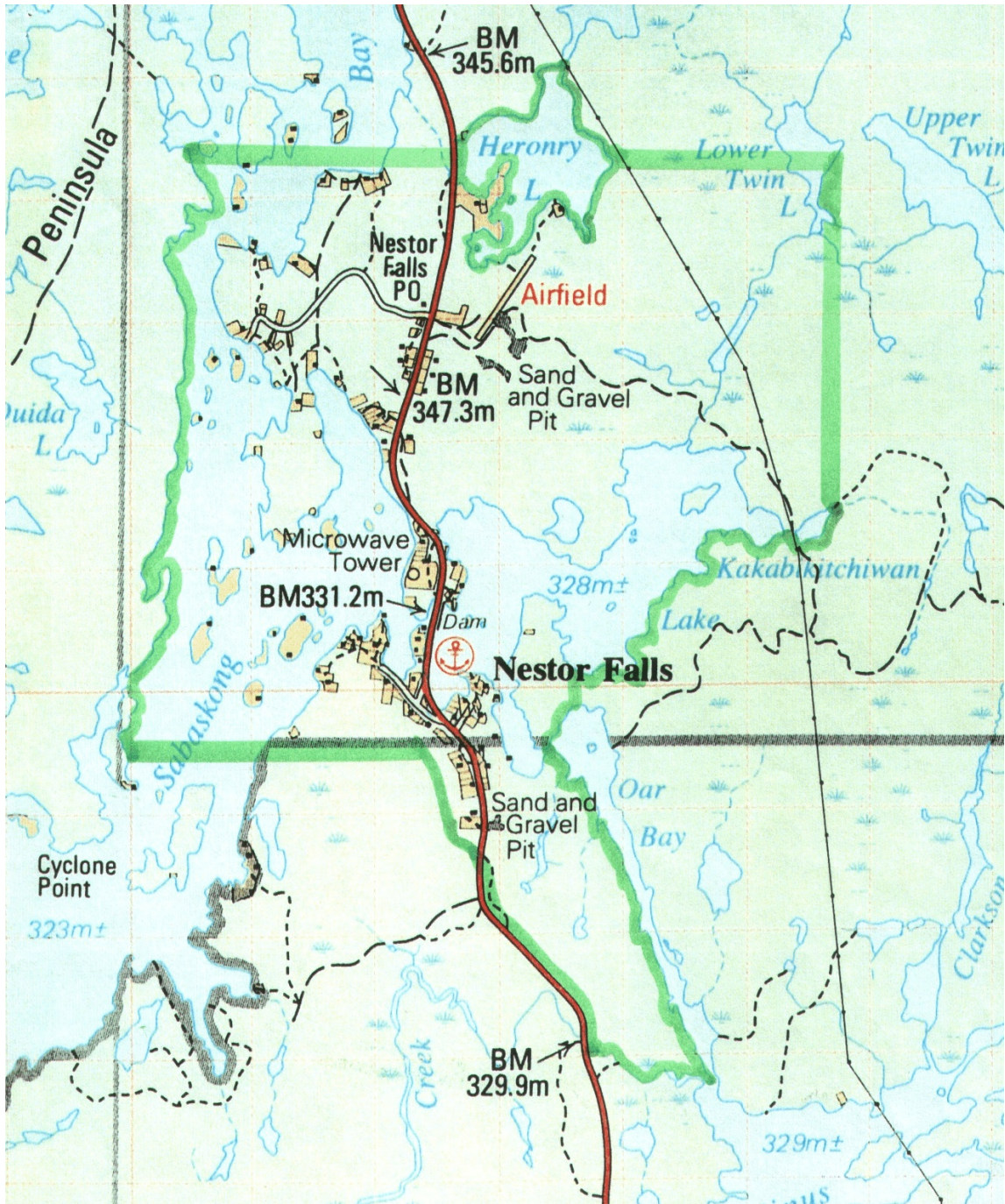
No Discharge of Weapons Zone
